Sub : **Enhancement of Honorarium of Part time non official Chairpersons of the State Public Sector Enterprises of Assam**

In supersession of the earlier Office Memorandum No. PE.7/79/157 dated 21-03-1984 and No. PE. 7/79/pt/25 dated 19-06-1984 of this Department, the monthly honorarium of the part-time non-official Chairpersons of the State Level Public Enterprises of Assam is hereby enhanced from Rs.1,000/- to a maximum of Rs.10,000/-. This will be applicable only for those Chairpersons who are not MPs/ MLAs or on regular pay roll so as not to allow double benefit of pay/salary/other similar benefit. The other perks entitled to the Chairpersons as per earlier OM No. PE. 7/79/157 dated 21-03-1984 will remain in force.

The expenditure relating to enhancement of honorarium and other benefits to the Chairpersons are to be met from the own resources of the State Public Sector Enterprises and the State Government will not provide any funds in this regard.

The enhancement will be effective from the date of issue of this OM without any retrospective/arrear benefit.
