OFFICE MEMORANDUM

Government of Assam have constituted a Standing Public Enterprises Selection Board for the selection of persons for appointment as Chief Executive of Public Enterprises under the State Government vide Government. Notification No. PE.67/79/47, date 26th September, 1980.

Whenever the post a Chief Executive of a Public Enterprises under the State Government is to be filled up, the Secretary to the Government of Assam in the concerned administrative department will intimate it well in advance to the Secretary to the Government of Assam. Public Enterprises Department (Member-Secretary of the Board) for convening the meeting of the Board with the approval of Chief Secretary to the Government of Assam (Chairman of the Board). The Board will recommend to the concerned Administrative Department the name of the person suitable for appointment as the Chief Executive.

Normally, the tenure of a Chief Executive in the Public Enterprises will not be less than three years.

Sir,

I am directed to invite a reference to the Government Notification No. PE. 69/79/46 dated 26th September, 1980 (copy enclosed for ready reference) and to say that the Government constituted a standing Public Enterprises Selection Board with the object of making selection of suitable persons for appointment as Chief Executive of Public Enterprises under the State Government. Although several years have passed since the constitution of the Board, Administrative Departments have not been approaching it for selection of persons for posts of Chief Executive. Most of the Public Enterprises of the State have been suffering from top managerial problems due to frequent transfer of officers and appointment of inexperienced persons. It may be appreciated that in the interest of efficient functioning of the State Public Enterprises suitable persons having aptitude for the work and whose services would be available for a period of at least three years at a stretch are selected as Chief Executive on the recommendation of the Board.

You are therefore, requested to ensure that all future appointments of Chief Executives of State Public Enterprises under your administrative control are done in consultation with the State Public Enterprises Selection Board.

I am directed to draw your attention to the procedure outlined in Government notification referred to above and reiterated in the letter under reference for placing of proposals for appointment of Chief Executives/ Managing 'Director/ General manger (as the case may be) of the State Public Enterprises before the Public Enterprises Selection Board (PESB) headed by the Chief Secretary to the Government of Assam as its Chairman for consideration of the Board.

It is regrettable that some Administrative Departments did not come up for prior consultation with the PESB for appointment of Chief Executives in some public enterprises. It will certainly also be appreciated that for efficient management of the State Public Enterprises and for better coordinated functioning prior consultation with the Public Enterprises Department is sinequanon under rule 54 C(b) of the Assam Rules of Executive Business wherein we will place the matter before the PESB.

In view of the above, you are requested to ensure that above procedure is followed in selecting Chief Executives of State Public Enterprises and prior consultation is done with the Public Enterprises Department in all such cases.
