#### **Notice Inviting Quotation**

- 1. Rates for each items should be quoted in typed form on company's letter head duly signed and having company's stamp/seal in the prescribed proforma -a and proforma-B (copy enclosed) including details of GST where ever applicable in a sealed envelope clearly superscribing "Quotation for I.T Items" and should be addressed to "The Secretary to the Govt of Assam, Industries, Commerce & Public Enterprises Department. The sealed quotations ( Proforma-A & Proforma-B duly filled in with required enclosures ) should be dropped in the Tender Box placed in the Industries, Commerce & Public Enterprises Department, Assam Secretariat, Block-C, 3<sup>rd</sup> floor by 1.00 P.M. on or before 1<sup>st</sup> Oct, 2021 positively. The quotations may be sent though post also to the Secretary to the Govt of Assam, Industries, Commerce & Public Enterprises Department, Room NO 409, Assam Secretariat, Block-A, 4th Floor, which should reach by 1.00 P.M. on or before 4st Oct, 2021 positively. The quotations received after due date/time and those which are not dropped in the tender box in stipulated time, will not be entertained at all. The quotations will be opened on the same day at 4.00 P.M in the office chamber of the Secretary to the Govt of Assam, Industries, Commerce & Public Enterprises Department , The renderers may send their representatives to remain present during opening of the quotations.
- 2. Earnest money amounting to Rs.20,000/- (Rupees Twenty thousand only)" in the form of Bank Draft payable in favour of Joint Secretary to the Govt. of Assam, Industries, Commerce & Public Enterprises Department should also be enclosed with the quotation which will be returned after finalization of the process to the unsuccessful firm/supplier whose tenders do not qualify. The earnest money of the successful firm/ supplier shall be retained till successful supply and installation of the items. Any quotation received without earnest money as stated above, will be rejected and not entertained at all.
- 3. The firm/supplier should be a authorized dealer/ manufacturer of the major items or should be a reputed supplier having a minimum five years' experience in supply of the major items of the list to the Government Ministries / Departments, PSUs, Statutory/ Autonomous Bodies etc.
- 4. Brochure/Catalogs of the items must be submitted with the proposal.
- 5. The sample should be displayed before supply of the items.
- 6. The firm should have valid documents of GST registration, PAN card,

- 7. Department may select more than one firm/supplier based on rates.
- 8. The firm should be in a position to supply approved items within 15 days from the date of placing order.
- 9. The approved items should be of standard quality as per specification and of the make specified. In case it is found that the items supplied are sub-standard or are of unacceptable nature, it would be open for the Department to return back these items. In case of repetition of such an act on the part of the firm, the Department may terminate the contract and also forfeit the Earnest Money.
- 10. The rates should be quoted in figure and words. The rates of items as specification specified in proforma-B must be submitted. However, rates of similar items with equivalent specification may also be submitted separately. Quotation received without tax details would be considered as inclusive of taxes and no increase in the price of the quoted rate would be considered for any reason during the contract period.
- 11. The payment will be made on satisfactory delivery and installation of the supplied items in the Department for which bill (in triplicate) will be required to be submitted to this Ministry. Defective item, if any, supplied by the contractor will be replaced by the firm/supplier immediately at his cost.
- 12. The decision of the Department would be final and binding in all respect. It may be noted that this Department reserves the right to accept or reject any or all quotation in full or in part without assigning any reason whatsoever and also reserves the right to make the purchases on the basis of quotations for each items.
